

Our Signature Projects allow the JLD to partner with like-minded sponsors in addressing community issues. Our three Signature Projects: Grants for Innovative Teaching (GFIT), Kids in the Kitchen (KITK) and Women L.E.A.D. champion creative approaches to encouraging teachers, empower children to make healthy choices and encourage young women to reach higher. Grants for Innovative Teaching

In 1992, the Junior League of Dallas created Grants for Innovative Teaching to provide grants of up to \$2,000 to Dallas ISD teachers. Sponsors include: Texas Instruments, Agnes Cluthe Oliver Foundation and Hillcrest Foundation

This year, GFIT will award \$89,340 to 50 grant recipients. The areas of instruction that were identified for these grants are: arts and cultural enrichment; diversity; literacy enrichment; special education; and science, technology, engineering, arts and math (STEAM).

This year's recipients will be recognized on Wednesday, Sept. 25 at 6:30 p.m. at the GFIT Teacher Recognition Ceremony and Reception at JLD Headquarters.

Provisional News

This year's 2018-2019 Provisional class has had a busy summer. Over 300 Provisionals attended Small Group socials in June and July. Each Small Group, which consists of 15 Provisionals, gathered together for a fun social event to meet each other and their Small Group Advisor. Provisionals recently completed their optional retreats; the daytime retreat was held at the Dallas Zoo and the overnight retreat was held just outside of Dallas.

There are 14 Provisional Projects where this year's class will be volunteering their time. Five of the 14 projects are with agencies the League currently doesn't support. The first project began on Saturday, Jul. 28 and the last project is scheduled to wrap up on Saturday, March 30, 2019.

Additionally, there will be a series of bus tours which will take place on Saturday, Aug. 25 and Saturday, Sept. 15 where Provisionals will visit four of JLD's partner agencies. The agencies included on these tours are: Texas Scottish Rite Hospital for Children, The Family Place, Twice Blessed House, Booker T.

Washington High School, Trinity River Mission, Literary Achieves, and Friends of the Dallas Public Library. Each bus tour will include a lunch and learn with agency leaders. Each agency that the Provisionals visit will represent one of the six Issue Areas that the JLD supports.





The first Provisional Course Meeting (PCM) will be on Wednesday, Sept. 19 and it will address our Violence Intervention Issue Area. The Keynote speaker for this meeting will be Jan Langbein from Genesis Women's Shelter. Each PCM event covers an Issue Area that the JLD focuses on and will have a speaker from one of our partner agencies in that Issue Area. 
