## **2011 FIVE OUTSTANDING YOUNG DALLASITES HONOREES**



JOHN ANSBACH is the chief legal officer for Mothers Against Drunk Driving (MADD). Through his work John is devoted to stopping drunk driving, supporting the victims of this violent crime and preventing underage drinking. John has also been an active member of the community through his volunteer activities and currently serves in the General Counsel Forum – Dallas Chapter (2008–Present), including being the 2011 President and a past Member of the Board of Directors. He has worked with Susan G. Komen for the Cure® in the Dallas Affiliate (2008–Present) as a Member of the Board of Directors. He served with the United States Organization for Bankruptcy Alternatives (2007–2010) and in 2009, 2010 as the legislative director and a member of the Board of Directors. Mr. Ansbach graduated from Texas A&M University and the University of Texas, School of Law.



HEATH CHEEK is an associate attorney with the firm of Bell Nunnally & Martin LLP where he represents Fortune 500 companies, small businesses, and individuals with complex commercial litigation including antitrust, labor and employment, patent and trade secrets, real estate, and securities. SARAH POLLEY is executive director at Vickery Meadow Learning Center; VMLC assists adults in some of the most impoverished areas of Dallas change their lives by teaching them to read and write in English and the center helps their young children get a head start in school by teaching them reading skills. Under Sarah's leadership, VMLC's budget has more than tripled, and the organization expanded to a second campus in West Dallas. Sarah is the chief fundraiser, while working with the Board of Directors to manage over 200 volunteers; most non-profits would need three or four staffers to handle all of these roles. Ms. Polley was recognized at the SMU Women's Symposium with the 2010 Profile in Leadership Award. She is a graduate of the Dallas Regional Chamber's Leadership Dallas. Sarah received her Masters in Education from Texas Christian University and her Bachelor of Arts in Latin American Studies from Southern Methodist University.



JEREMIAH QUARLES is a project manager for the Office of Economic Development for the City of Dallas; it is in this role that he has established a profound reputation in his industry as he has influenced several businesses to stay and/or grow their operations in the City of Dallas, thus, producing millions of dollars for the city. As a member of Urban Financial Services Coalition, Jeremiah has spearheaded efforts to provide a school based financial literacy course, facilitated by our organization at Southern Dallas schools, in order to fight against financial "illiteracy" in these underserved communities. He quickly demonstrated his leadership skills, earning him the president-elected role as chapter programs assistant vice president. Of the more than 600 young Americans honored over the past 73 years, many were recognized before the achievements for which they are now best known. Honorees include: John F. Kennedy, Gerald R. Ford, Ann Bancroft, Gale Sayers, Elvis Presley, George H.W. Bush and Bill Clinton.
