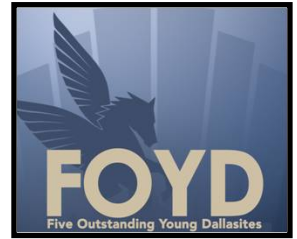

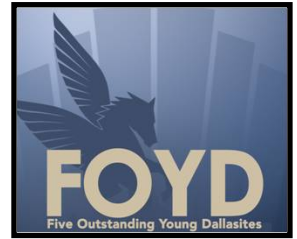
JOHN ANSBACH

Chief Legal Officer for Mothers Against Drunk Driving (MADD)

John Ansbach is the chief legal officer for Mothers Against Drunk Driving (MADD). Through his work John is devoted to stopping drunk driving, supporting the victims of this violent crime and preventing underage drinking. John has also been an active member of the community through his volunteer activities and currently serves in the General Counsel Forum – Dallas Chapter (2008–Present), including being the 2011 President and a past Member of the Board of Directors. He has worked with Susan G. Komen for the Cure® in the Dallas Affiliate (2008–Present) as a Member of the Board of Directors. John served with the Texas Association of Business (2010–Present) as a member of the Board of Directors. He served with the United States Organization for Bankruptcy Alternatives (2007–2010) and in 2009, 2010 as the legislative director and a member of the Board of Directors. He served on the National Foundation for Women Legislators (2010–Present) as the 2011 treasurer and member of the Board of Directors. He is a current member of the Association of Corporate Counsel (2007–Present) and the Dallas Bar Association (1996–present). John also lectures at Southern Methodist University's Dedman School of Law as a guest lecturer (Government Relations & Lobbying 2011) and served at The University of Texas School of Law as a guest lecturer (Advanced Litigation 2004–2008).

His honors include Dallas Business Journal "40 Under 40" (2011), Dallas Business Journal – Best Corporate Counsel (2010), D CEO Magazine – Outstanding Corporate Counsel Finalist (2010), and a Marshall Memorial Fellow, German Marshall Fund (Summer 2011). Mr. Ansbach graduated from Texas A&M University and the University of Texas, School of Law. John resides in Lakewood with his spouse, Cindy Kang Ansbach, and their two dogs. 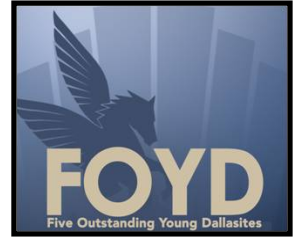
HEATH CHEEK

Heath Cheek is an associate attorney with the firm of Bell Nunnally & Martin LLP where he represents Fortune 500 companies, small businesses, and individuals with complex commercial litigation including antitrust, labor and employment, patent and trade secrets, real estate, and securities. Heath exhibits the same level of commitment to his community as he does with his clients. He founded and serves as chairman of the Texas Tech Quarterly Business Briefing, an event that provides scholarships to economically-disadvantaged, Dallas County students attending Texas Tech. Over the past three years, Heath has raised \$65,000 in scholarships for dozens of students, many of whom would not be able to attend college if it weren't for this aid. Heath was selected to serve on the North Texas Super Bowl XLV Host Committee where he and his committee of 100 were tasked with selling game and sponsorship packages through the NFL On Location program. Additional community and professional affiliations include Dallas Association of Young Lawyers, Dallas Museum of Art Junior Associates, and Texas Tech Alumni Association of Dallas.

Mr. Cheek graduated *magna cum laude* from Texas Tech University where he received his Bachelor of Arts in History and Political Science. He graduated from Baylor University School of Law where he was executive editor of the *Baylor Law Review*. Andrea Gage, recruiter for Texas Tech University, nominated Heath for the 2011 FOYD distinction. She wrote, "You may notice that most of Heath's involvement revolves around providing scholarships to needy students and there is a reason for that. Heath is a first-generation college graduate who grew up on a farm in the small West Texas town of Chillicothe. Due to drought and several years of bad crops, Heath's parents were not able to provide money for Heath's college education. Nevertheless, through the generosity of scholarship donors, Heath was able to attend Texas Tech University and, eventually, Baylor Law School. Heath has always viewed those scholarships as 'loans' that he intends to pay forward to high school students who experience similar hardship."

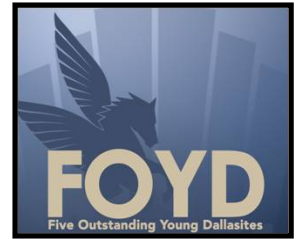
CARL PANKRATZ

Despite his busy career, Carl is committed to making his city of residence, Rowlett, great. In June 2011, Mr. Pankratz was elected to the Rowlett City Council, Place 3 in a run-off election against an incumbent. The Texas Bar Association recently elected Carl to fellow; this honor is bestowed to the top 1/3 of 1% of all Texas attorneys. He has been selected as one of 20 lawyers to participate in the State Bar of Texas Leadership Class, a program which recognizes professional, community and personal accomplishments. 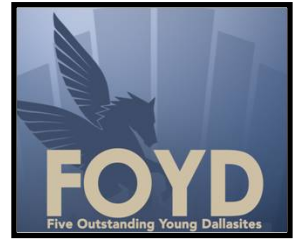
SARAH POLLEY

Executive Director, Vickery Meadow Learning Center

Sarah Polley is executive director at Vickery Meadow Learning Center; VMLC assists adults in some of the most impoverished areas of Dallas change their lives by teaching them to read and write in English and the center helps their young children get a head start in school by teaching them reading skills. Under Sarah's leadership, VMLC's budget has more than tripled, and the organization expanded to a second campus in West Dallas. Sarah is the chief fundraiser, while working with the Board of Directors to manage over 200 volunteers; most non-profits would need three or four staffers to handle all of these roles. Sarah has shepherded VMLC through these tough economic times and made it stronger than ever. The non-profit was recently recognized by the patrons of the Crystal Charity Ball, who selected VMLC to be a beneficiary this year. Ms. Polley was recognized at the SMU Women's Symposium with the 2010 Profile in Leadership Award. She is a graduate of the Dallas Regional Chamber's Leadership Dallas. Sarah serves on the steering committees for Literacy Coalition of Greater Dallas and With One Voice Immigration Coalition.

Ms. Polley received her Masters in Education from Texas Christian University and her Bachelor of Arts in Latin American Studies from Southern Methodist University. Wilson Aurbach, colleague, nominated Sarah for this honor.
